# All Saints Church Kingston-Upon-Thames

## Seven Saxon Kings Embroidery Project Dedication & unveiling of three more Embroideries



On Sunday, 7th January 2024 at All Saints Church Kingston, RW Bro Charles Aspinell, Assistant Grand Master, accompanied by RW Bro Lionel Mee Provincial Grand Master for Sussex and his Deputy, VW Bro Mark Donovan, together with a contingent of Sussex brethren and their wives, attended the Epiphany Carol Service followed by the Dedication and unveiling of three more Embroidered Tapestries in the Church's Seven Saxon Kings Embroidery Project.

The Congregation of more than 300, was headed by the Deputy Mayor of Kingston, Councillor Richard Thorpe, with the Rev Joe Moffat, Vicar of All Saints Church officiating.





After the Carol Service everyone moved to the East wing of the church where the three new Embroideries depicting Edmund, Eadred and Eadwig were Dedicated by the Rev Joe Moffat and unveiled by the Deputy Mayor.









Following our having donated and presented the first of these embroideries depicting King Athelstan in September 2021, this brings to four the number of embroideries now in situ. Fund-raising is continuing to enable the remaining three - depicting Edward the Elder, Edward the Martyr and Ethelred - to be completed, and which the Church hopes for completion of the Project within the next year or two.

## The Coronation Stone at Kingston.

## From the Leeds Intelligencer - Saturday 28 September 1850

On Thursday week, the inauguration of the coronation stone of the Anglo-Saxon Kings, the ancestors of our illustrious Queen, took place in the presence of the Mayor and corporation of Kingston, attended by the burgesses and a numerous assembly of visitors.

The Right Worshipful the Provincial Grand Master of the Freemasons of the county of Surrey, assisted by the brethren of the Province and other masons, took a prominent part in the ceremony. This stone, until lately, stood on the north side of the old church.

According to Speed, the historian, nine of our Saxon Monarchs were crowned in Kingston, the stone being used as the Royal seat during the ceremony. It has been removed, during the present Ice Michan

mayoralty, to the centre of an open space near the savings-bank, directly opposite High-street, at the turning into the Portsmouth-road. There it is placed on a heptagonal pedestal of granite, which stands on a circular base of the same material.

It being uncertain whether two of the kings mentioned by Speed were crowned at Kingston, the corporation have selected the following seven, whose names, with the dates of their respective coronations, are inscribed on the faces of the pedestal, vis.:— Athelstane, a.d. 924; Edward, a.d. 940; Edred, a.d. 946; Edgar, a.d. 959: Edward II, a.d. 975; Ethelred II, a.d. 975; and Edmund II, a.d. 1016.

The monument is encompassed with iron railings, having a pillar finished with pinnacles at each of the seven angles. At the conclusion of the ceremony the mayor, Freemasons, and visitors partook of an elegant dejeuner, and other festivities followed for the entertainment of all classes of inhabitants.



The Coronation Stone is an ancient sarsen stone block which is believed to have been the site of the coronation of seven Anglo-Saxon kings. It is currently located next to the Guildhall in Kingston upon Thames, a town in the Royal Borough of Kingston Upon Thames in Greater London.

In Old English, *tun*, *ton* or *don* meant farmstead or settlement, so the name Kingston appears to mean farmstead of the kings. A local legend that these Saxon coronations gave Kingston its name is contradicted by the records of the 838 council.

Æthelstan was consecrated King at Kingston in 925, Eadred in 946 and Æthelred the Unready in 979. There is also some evidence that Edward the Elder, Edmund I, Eadwig and Edward the Martyr were consecrated in the town. The stone is protected by low railings

According to John Stow, writing in the late sixteenth century, Æthelstan was crowned on a stage in the marketplace, but it was later believed that the kings were crowned in the ancient church of St Mary, which collapsed in 1730. A large stone block was recovered soon afterwards from the ruins of the chapel, and it has since been regarded as the Coronation Stone of the Kings of the English.

It was used for a time in the late 18th century to the early 19th century as a mounting block, but in 1850 it was placed in the market place on a

plinth in front of the old Town Hall on the site now occupied by the 'Market House' today, which had the names of the seven kings believed to have been crowned on it inscribed around the side.

In 2017, Kingston Council was considering an option of re-siting the coronation stone from the Guildhall's frontage back to its original location within the churchyard of Kingston's old parish church, All Saints' Church.

The Acting Marshal, W.Bro. Roger Short, called the Brethren to order to receive the acting Worshipful Master, W.Bro. Satish Dhir, who opened the Court in due form at 6pm. The business of the court was concluded, including congratulations to Satish & Varinder Dhir on their elevation to the Ancient Masonic Order of Alfred the Great.

The court was closed at 6:30pm in due form and solemn prayer.




After the regular business of the Court had been completed W.Bro. Gordon Smith gave a talk entitled 'If it looks right, it is right', which was very well received. The talk looked at architecture and the role of the Medieval Mason by looking at Churches, Abbeys and Cathedrals and how they were designed and built at the time of King Athelstan.

The talk looked at geometry and proportion using the basic design of a Centre Point, a Triangle, a Circle, and a Square – does this sound familiar?

Most buildings of that time were based on either a triangle or a square. Later, the ratio of 1 to 1.618 was found to be the most pleasing to the eye, and most Cathedrals were built to this plan.

The Court was then closed, and a potential Candidate for Instruction, Bro. Kenny Kin Fat Ng, was invited into the Court to hear about the Order and how a Court is set out.
